HEREBY INDEMNIFY the Association against all liabilities which it might incur or suffer in connection with such Carnet. We undertake immediately upon receipt by the Association of any demand for payment in respect of the abovementioned articles, to pay to the Association such sum as may be required by the Association to meet such demand. The sum shall be paid by us upon receipt by us of a certificate from the Association referring to this indemnity and detailing the sum demanded and the identity of the authority demanding payment. The certificate shall be sufficient evidence of the facts therein stated, including the lawfulness of the demand.

It is understood that the Association will immediately notify us of the termination of its liability in connection with the said Carnet. Termination of liability will occur only when such document is returned to the Association either unused or endorsed to the effect that the articles enumerated above have been exported from the countries concerned. At any time before the Association has given us any such notice we shall be entitled to pay to the Association the maximum amount of our liability under this indemnity, whereupon our liability under this indemnity will likewise lapse.

We understand that claims against the Association in connection with the said Carnet will be liable to arise if the vehicle and articles detailed above are not exported within a limited time after import, or if there should be any breach or non-observance of the conditions under which such vehicles and articles may be imported for a limited time without payment of duties. These conditions apply to countries where the Carnet is endorsed after departure from the country of current registration. The bank reserves the right at any time and of its entire discretion to obtain cancellation of this guarantee by depositing the said amount in cash with the Automobile Association of South Africa, before giving written notice of its intention to do so.
